- This 12 credit qualification has a selection of units ranging from 3 credits, 4 credits, 6 credits, 9 credits and a 10 credit unit. All are vocational and relate to the sector in the title. This qualification is 100% vocational in its content.
- The Award provides you, who especially have limited qualifications in this area, to make bite sized developmental progression at Level 1. The qualification offers you a flexible bank of units that can be tailored into specialised learning packages in areas of interest that deliver an introduction to particular sectors within the fashion and textiles sector (at Level 1) and providing an overview of potential occupations and job roles.

If there are larger and/or smaller versions of this qualification at the same Level, why should a learner take this particular one?

This qualification is part of the Fashion and Textiles suite (Award/Certificate/Diploma) and is designed to provide you with the opportunity for incremental learning. The different size qualifications add depth and breadth to the specialism being studied without duplicating the learning covered by each qualification.

The suite is designed to be flexible, allowing you to choose units that best fit your individual circumstances and level of achievement, whilst at the same time ensuring that essential areas of knowledge and skills for progression are covered. The larger sized Certificate (24 credits – potentially an additional minimum 2 units depending upon unit selection) allows you to develop across a broader area dependent on your specific needs. This larger size of qualification within the suite provides you with the opportunities to add further units at a later stage, as a progression route to another size or level of qualification (e.g. Level 1 Diploma in Fashion and Textiles or for progression to other qualifications.

The addition of extra units supports the transfer across specialist sectors within the fashion and textiles industries.
