Level 2 Certificate in Manufacturing Sewn Products (NVQ) (500/5962/2)

Key Features

The qualification will enable learners to develop the knowledge and skills required for work in the sub-sectors of apparel and textiles.

The qualification has been developed in association with the Sector Skills Council (SSC) for apparel, footwear, textiles and related businesses. It is a work-based qualification that develops specialist and transferable professional skills, engages learners with current industry practice, and prepares them to progress onto further qualifications or employment opportunities.

Candidates will gain insight into core activities such as Health, safety and security at work, How to carry out routine maintenance of tools and equipment, including recognising potential problems and keeping the work area clean and tidy, and more within the apparel and textiles industry.

The qualification will prepare learners for progression to the Level 3 Certificate in Apparel Manufacturing Technology, into employment and/or further education and training.

The qualification is regulated by Ofqual.

Who are these qualifications for?

These qualifications are designed for young people aged 16+ who are looking for a vocational qualification for progression into further education or employment.
